I. Call to Order – Leslie Eschenbacher, Chairperson: The meeting was called to order at 8:30 AM by Leslie Eschenbacher.

II. Approval of December Steering Committee Minutes (attached): Laura Love made a motion to approve the February 24, 2021 meeting notes. Beth Eurich seconded the motion. All were in favor.

March HSCC General Member Meeting Minutes: March 24, 2021 General Meeting notes attached for your review.

III. Bay County Health Department COVID-19 Update: Dept. on Aging - Given 100 vaccine shots to homebound seniors in Bay County. Working with Bay County Housing along with Pine View and Center Ridge apartments to get individuals vaccinated (Pfizer Vaccines)). BABH also has a vaccination clinic open to all consumers, staff and family members, and also to any resident residing in Bay County (Moderna Vaccines). Health Department - still at 17% activity rate (staying at same rate of about 60 confirmed cases per day). Health Department was at approximately 800 – 1000 vaccines per day 2 – 3 weeks ago. Have decided to offer more evening clinics (numbers are decreasing in the amount of vaccines given out per day). Looking out a given out incentives to get more individuals to come in to get their vaccination. Targeting high school seniors (especially for those students in sports) to receive the vaccine (if vaccinated they are exempt from quarantine as long as they are not exhibiting any symptoms). Trying to come up with ideas of how to get more individuals vaccinated (goal is to reach 70% individuals vaccinated). Doing really well with getting seniors vaccinated. 38-39% fully vaccinated in Bay County. Most walk-in clinics don't have to pre-register to receive vaccines. 1/5 of all cases are vaccinated are under 18. There are two age groups that are not getting vaccinated: Ages of 16-35 - don't think they need one - indestructible); and 35-60 - more resistant to the process.

- **IV. BACF Grant Application Review:** Received a proposal from LifeClinic Community Resources (see attached). Currently there is \$1643.00 available through the HSCC Fund (available through the year). There will be one more funding cycle through the fall for additional projects to come forward. After further discussion, it was decided that this committee was not interested in funding this proposal at this time (no motion needed).
- V. Return to Learn Updates: Majority of high schoolers are remote for another week.
- VI. Community Response Update: A group will be meeting on Friday to reach out to individuals to get them vaccinated. Looking at given out an incentive for those individuals who receive their vaccination (i.e. drawing for a car lease for two years those vaccinated would go into the drawing).
- VII. Trauma Informed Communities/MiHIA ACE's Resiliency Workgroup Update: In January there was a virtual MACC to train trainers. This was a 2-day training and about 30 individuals attended. Very successful experience. Planning in May to have everyone come back together from the previous 2 trainings to talk about opportunities and give updates. At next meeting there will be further discussion regarding building positive assets. Working with MiHIA to support all the work ACE's and Resilience is doing.
