- I. **Call to Order – Leslie Eschenbacher, Chairperson:** The meeting was called to order at 8:30 AM by Leslie Eschenbacher. Introductions were made.
- II. **Review of/and Additions to the Agenda:** Leslie Eschenbacher made a motion to approve the agenda as written. Laura Love seconded the motion. All were in favor.

- IV. **COVID-19 Response Updates:**
Bay County Health Department COVID-19 Update: Cases have gone down dramatically in the past two weeks (87 individuals have tested positive – approximately 600 tested positive 6 months ago). 8% of individuals are testing positive (much lower than the previous 22% that we had 6 weeks ago). There are approximately 12 individuals admitted to McLaren (1% in the ICU) due to COVID. Bay County is approximately 57% covered with at least one dose of the entire adult population who have received the COVID vaccination. No appointment is needed to be vaccinated at any of the clinics that offer the vaccine (including several doctor’s offices). Storage and handling requirements have improved significantly. In the last week 30% the age group of 19 and below were vaccinated.
United Way / COVID-19 Community Response Team: This committee will be disbanding into smaller groups.
Department of Health and Human Services Update: Deferred.
Department on Aging Update: Total count of 337 home bound individuals have been vaccinated by Department of Aging thus far. A list of over 1700 individuals from the State of Michigan of home bound individuals that need to be vaccinated were given out. The list has been decreased to 713 – currently working on this part).
